## Application Guidelines for the Project on Training of Doctoral Students at Yamaguchi University through Interdisciplinary Research Practice For FSJ 2025

### 1. Purpose of the program

Doctoral students are important human resources who will determine the future of Japan, and are the source of various technological developments and comprehensive knowledge that are indispensable for the realization of Society 5.0 as stated in the 6th Science, Technology, and Innovation Basic Plan. They are also expected to play an important role in "innovation creation," which is one of the pillars of the Basic Plan. To this end, doctoral students are required to cultivate the necessary skills and to go out to practice the acquired skills (e.g. internship, overseas training, etc.).

This project selects outstanding doctoral students who are willing to be directly involved in the creation of science, technology, and innovation in Japan, and supports their living and research expenses. Selected students are required to attend various educational programs offered by the Yamaguchi Future Creation School (YFCS, Yamaguchi Mirai Souhatsu Jyuku) as students of the YFCS, and actively participate in "Shin-Monju Group" activities, which aim to provide opportunities for interdisciplinary research and cultivate transferable skills.

This project has been adopted by the program "*Support for Pioneering Research Initiated by the Next Generation (SPRING)*" of the Japan Science and Technology Agency (JST).

### 2. Eligible students

Those who will newly enter or advance to the Graduate School of Medicine (Doctoral Course or the Latter Period of Doctoral Course), Graduate School of Sciences and Technology for Innovation (the Latter Period of Doctoral Course), Graduate School of East Asian Studies, and Joint Graduate School of Veterinary Medicine of Yamaguchi University (hereinafter referred to as "Doctoral Course") in April, 2025. And those who meet the requirements to fill the vacancy at the YFCS(\*1). All the applicants should have a strong will to be directly involved in the creation of science, technology, and innovation in Japan after completing the doctoral program.

(\*1) Second-year doctoral students and third-year doctoral students may also apply to fill the vacancies left by those who are no longer eligible for support from the program. In this case, the period of support will be the remaining period of enrollment. However, those whose remaining period of study is six months or less from the standard term of study (three years for a three-year doctoral course or four years for a four-year doctoral course) are excluded.

Those who fall under any of the following categories are not eligible.

- (1) Government-sponsored international students or international students receiving scholarships or other support from their home countries
- (2) Research Fellows of the Japan Society for the Promotion of Science (JSPS)
- (3) Working students and others who have a stable income such as salary or executive compensation (estimated 2.4 million yen/year or more) at a level sufficient to cover living expenses
- (4) Others who are not eligible for support according to the regulations of JST or Yamaguchi University

### 3. Number of new selected students

The total number of new selected students will be approximately 13 in total.

※1 Due to the purpose of the program, students with six months remaining (3rd year students for 3-year doctoral programs entering in October, or 4th year students for 4-year doctoral programs entering in October) are not eligible for this scholarship.

※2 Those entering in October (new students, current students other than those in (\*1) above) are not eligible to apply this time since the application period is scheduled to begin in August or September.

### 5. Amount equivalent to living expenses and research expenses

The estimated amounts to be paid in FY2025 are as follows.

- (1) Living expenses: 2,280,000 yen/year
- (2) Research expenses: 300,000 yen/year

※Additional allocations may be made based on a careful examination of the research content of the application documents.

### (3) Others

Up to 300,000 yen/year per project will be provided as project expenses for research themes

that integrate different fields proposed by the Shin-Monju Group.

The amount may be increased or decreased depending on the budget situation.

(1) Application form (Form 1) must be submitted by e-mail to the section in charge of each graduate school by 12:00 p.m. on February 10 (Mon.), 2025. The file must be converted to a PDF file (make sure that the format is correct) and the file name must be "Student ID Number (one-byte number) Name\_01 Application Form" (e.g., 2100010012 Taro Yamaguchi\_01 Application Form).

## 8. Selection Method and Viewpoints of Selection

The Selection Committee for Support Students will conduct the first round of selection (document review) and the second round of selection (interview).

Applicants who pass the first round of selection will be notified of the method of the second round of selection. Please note that depending on the results of the first round of selection, the selection of applicants may be made based on the results of the first round of selection, without conducting the second round of selection.

The main viewpoints of the screening process are as follows.

### (1) Research plan in the doctoral program

- Is the applicant's research background, objectives, and research content explained in an easy-

to-understand manner?

- Whether the applicant's independence and autonomy in setting the research theme are evident.
- Is the research plan appropriate?

(2) The applicant's ideas and perspectives on interdisciplinary fusion research

- Is the research theme proposed as an interdisciplinary fusion research excellent?
- Does the applicant have his/her own ideas about interdisciplinary fusion research?
- Does the applicant have a clear understanding (explanation) of what the applicant can contribute to the interdisciplinary fusion research?
- Does the applicant show enthusiasm for and willingness to participate in interdisciplinary fusion research?

(3) Self-analysis

- Does the applicant clearly know what he/she should do based on the self-analysis?

(4) Applicant's vision for the future

- Will the applicant be able to contribute to the development of research and innovation in Japan in the future?
- Does the applicant have a strong desire to contribute to the development of research and innovation in Japan in the future?
- Does the applicant have a strong desire to develop his/her own career path?

9. Schedule of this project (tentative)

- First round of selection (document review) : Mid-February- 2025
- Second round selection (interview) : March 3 (Mon.) to 7 (Fri.), 2024 (To be conducted online; please secure a date. Details will be announced at a later date.)
- Selection decision : Late March 2025 (tentative)

The amount equivalent to living expenses will be paid retroactively from April 1, 2025. Please note that international students will be eligible for the payment from the date of their arrival in Japan.

10. Responsibilities of selected students

Selected students are responsible for the following. Failure to fulfill these obligations may result in revocation of their status as a selected student.

- (1) Attend the various programs offered by the Yamaguchi Future Creation School (YFCS) and participate in the activities of the Shin-Monju Group.
- (2) To comply with the rules and regulations set forth by Yamaguchi University when conducting research.
- (3) Attend the research ethics education e-learning (eAPRIN) and training sessions based on the Misconduct Prevention Plan for Public Research Funds.
- (4) Cooperate in career follow-up surveys conducted by JST and Yamaguchi University for about 10 years after graduation in order to verify the effectiveness of the YFCS program. For this purpose, the students must register with JGRAD and update your information as explained in (02\_(attached)).

(5) Even if you do not wish to participate in an internship at present, you must register with the matching system of the "Cooperative Education through Research Internships Promotion Council" as explained in (02\_(attached)).

#### 11. Handling of personal information

Personal information contained in the application documents will be used for the purpose of this selection and program implementation, and may be provided to JST as necessary. The names of selected students will be published on the Yamaguchi University website.

#### 12. Procedures required for receiving a research aid after being selected student

The research aid (190,000 yen per month) is treated as miscellaneous income subject to taxation. Therefore, program students themselves must complete the following procedures; (1) Tax Return, (2) National Health Insurance, and (3) National Pension Insurance.

It should also be noted that, the amount of payment for (1) - (3) above is related to the amount of income from the previous year (January 1 to December 31). In this program, the total amount of income received in the second year is higher than the one in the first year, so the amount paid in the second year tends to be higher. Therefore, the amount you must pay in the first year is different from the one in the second and subsequent years of the program.

##### (1) Tax Return and other taxes

(Tax Return)

Since the research aid\* is taxable as miscellaneous income, course students are required to file their own tax returns and obliged to pay "income tax".

\*Since it is not a "scholarship," it is not tax-exempt income.

(Note) Tuition and other research expenses are deductible as necessary expenses.

(Note) In order to file a tax return, it is necessary to keep records of income and expenditures, receipts and other evidence.

(Inhabitant Tax)

The taxpayer is obliged to pay "inhabitant tax" to the municipality in which he/she resides according to the taxable amount. The system of inhabitant tax is a levy tax system in which local governments calculate the tax amount and notify the taxpayer.

(Tax Treaty)

For international students, tax treatment may differ depending on the tax treaty between Japan and the student's home country. If you have any questions, please consult with us if you have any questions.

##### (2) National Health Insurance

If a course student is enrolled in his/her family's health insurance, etc. as a dependent, and if he/she receives research aid and starts earning a constant income of 1.3 million yen or more per year, he/she will no longer be a dependent of his/her family's health insurance, etc. and

will be required to enroll in the National Health Insurance.

(Note) Tell the person who support you as a dependent (parent, etc.) to check with his/her workplace

about his/her handling of dependent care benefits, etc. At that time, be sure to inform them that research aid is "miscellaneous income" subject to taxation.

(Note) The enrollment procedures and the amount of National Health Insurance premiums varies depending on the municipality, so please check with the National Health Insurance office at the city (ward) office or town hall where you reside.

### (3) National Pension Insurance

In principle, all people between the ages of 20 and 60 who live in Japan are insured under the National Pension Plan and are required to pay National Pension Plan premiums. Students are allowed to defer payment of the premiums if their income for the previous year is below a certain level\* under the "Special Student Payment System".

If the student is no longer eligible for the deferment under the "Special Student Payment System" due to receiving research aid, the student will be obliged to pay the National Pension Insurance premiums.

\* The income of the person for the previous year is below a certain level.

Approximate amount: 1,280,000 yen + number of dependents × 380,000 yen + deduction for social insurance premiums, etc.

(Note) For specific National Pension Insurance procedures, please contact the National Pension Office at the city (ward) office or town hall where you reside.

For details on procedures related to taxes, insurance, and pensions, please consult with a specialized contact. The SPRING office is unable to provide accurate information.

(2) This recruitment is not for the doctoral program entrance examination at Yamaguchi University. To enroll in our doctoral program, you must pass a separate entrance examination conducted by the graduate school.
